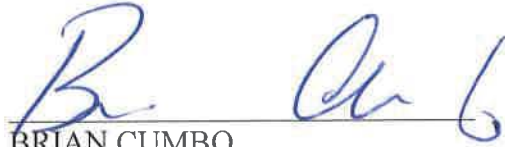
**MARTIN WATER DISTRICT'S REPORT REGARDING
EXCESS INTEREST CHARGED BY AND PAID TO
EVANS HARDWARE & CI THORNBURG**

Comes the Martin County Water District, by counsel, pursuant to the Public Service Commission Order entered on July 22, 2020, and makes the following Report:

1. Martin County Water District staff met with Evans Hardware and representatives of CI Thornburg.
2. Because both vendors have a long standing relationship with the Martin Water District, and because of their forbearance and willingness to continue to extend credit when they probably should not, it was determined that informal meetings were the most appropriate initial approach.
3. Evans Hardware agreed to eliminate the interest provision entirely, and documentation is attached hereto as Exhibit 1.
4. CI Thornburg has agreed to reapply service charges paid in the past to the principal balance. They will remove all current service charges. They will be sending current statements showing new total balance owed which will reflect the already paid service

charges being applied to the principal charges. CI Thornburg's email is attached hereto as Exhibit 2.

5. The Martin County Water District will supplement this filing immediately upon receipt of CI Thornburg's updated statements.
