Notice of Kentucky Water Quality Standards Triennial Review

Kentucky Division of Water

August 15, 2024

In accordance with the federal Clean Water Act (CWA), Congress gave states the responsibility of establishing objectives or goals for managing, maintaining, and enhancing water quality which are commonly referred to as state water quality standards (WQS). Every three years states must review their water quality standards, hold a public listening session, and provide a 45-day public comment period pursuant to Section 303(c)(1) of the CWA. This collective process is called a "Triennial Review".

The Kentucky Division of Water (the "Division") hereby gives notice of its intent to conduct a hybrid Triennial Review public listening session and collect public comments to satisfy the requirements of Section 303(c)(1) of the CWA. The listening session and comments received will assist the Division in determining what revisions, if any, to its WQS may be appropriate in this Triennial Review. Following the comment period for this Triennial Review, and to comply with the federal CWA, the cabinet intends to update the Domestic Water Supply intake location table and add a number of Outstanding State Resource Waters (OSRWs) to 401 KAR 10:026 and Exceptional Waters to 401 KAR 10:030 pursuant to the administrative regulation promulgation process contained in KRS Chapter 13A (Administrative Regulations). These lists have not been updated since 2018.

Any technical or scientific information, reports, or data should be included.
